Health & Safety General Standards

Policy Statement

We believe that the Health and Safety of children is of paramount importance. We make our setting a safe and healthy place for children, parents, staff, and volunteers.

- We aim to make children, parents, staff, and volunteers aware of Health and Safety issues and to minimise the hazards and risks to enable the children to thrive in a healthy and safe environment.
- Our member of staff responsible for health and safety is **Fiona Batstone**.
 - She is competent to carry out these responsibilities.
 - She will undertake health and safety training regularly.
- We display the necessary Health and Safety poster in **The Kitchen**.

Insurance Cover

We have Public Liability Insurance and Employers' Liability Insurance. The certificate for Public Liability Insurance is displayed in **The Office**.

Procedures

Awareness raising

- Our induction training for staff and volunteers includes a clear explanation of Health and Safety issues, so that all adults can adhere to our policy and procedures as they understand their shared responsibility for Health and Safety. The induction training covers matters of employee well-being, including safe lifting and the storage of potentially dangerous substances.
- We keep records of these induction training sessions and new staff and volunteers are asked to sign the records to confirm that they have taken part.
- We explain Health and Safety issues to the parents of new children, so that they understand the part played by these issues in the daily life of the setting.
- As necessary, Health and Safety training is included in the annual training plans of staff, and Health and Safety is discussed regularly at our staff meetings.
- We operate a no-smoking policy.
- We make children aware of Health and Safety issues through discussions, planned activities and routines.
- We actively Risk Assess with staff, visitors, and children as we move in, around and outside of our setting.

Windows

- Low level windows are made from materials that prevent accidental breakage.
- We ensure that any blind cords are secured safely and do not pose a strangulation risk for young children.

Doors

- We take precautions to prevent children's fingers from being trapped in doors.

Floors and walkways

- All our floor surfaces are checked daily to ensure they are clean and not uneven, wet, or damaged. Any wet spills are mopped up immediately.
- Exits and stairs are left clear and uncluttered.

Electrical/Gas Equipment

- We ensure that all electrical/gas equipment conforms to safety requirements and are checked regularly.
- Our boiler/electrical switch gear/meter cupboard is not accessible to the children.
- Fires, heaters, wires, and leads are properly guarded, and we teach the children not to touch them.
- We check storage heaters daily to make sure they are not covered.
- There are sufficient sockets in our setting to prevent overloading.
- We switch electrical devices off from the plug after use.
- We ensure that the temperature of hot water is controlled to prevent scalds.
- Lighting and ventilation is adequate in all areas of our setting, including storage areas.

Storage

- All our resources and materials, which are used by the children, are stored safely.
- All our equipment and resources are stored or stacked safely to prevent them accidentally falling or collapsing.

Outdoor area

- Our outdoor area is securely fenced. All gates and fences are childproof and safe.
- Our outdoor area is checked for safety and cleared of rubbish, animal droppings and any other unsafe items before it is used.
- Adults and children are alerted to the dangers of poisonous plants, herbicides, and pesticides.
- We leave receptacles upturned to prevent collection of rainwater. Where water can form a pool on equipment, it is emptied and cleaned before children start playing outside.
- Our outdoor sand pit is covered when not in use and sand is changed regularly.
- We check that children are suitably attired for the weather conditions and type of outdoor activities; ensuring that sun cream is applied, and hats are worn during the summer months.
- We always supervise outdoor activities; and particularly children on climbing equipment.

Hygiene

- We seek information from the Public Health England to ensure that we keep up to date with the latest recommendations. We share any relevant updates with parents.
- Our daily routines encourage the children to learn about personal hygiene.

- We have a daily cleaning routine for the setting, which includes the main room, kitchen, rest area, toilets, and nappy changing areas. Children do not have unsupervised access to the kitchen.
- We have a schedule for cleaning resources and equipment, dressing-up clothes, and furnishings.
- The toilet area has a high standard of hygiene, including hand washing and drying facilities and disposal facilities for nappies.
- We implement good hygiene practices by:
 - cleaning tables between activities
 - cleaning and checking toilets regularly
 - wearing protective clothing - such as aprons and disposable gloves - as appropriate
 - providing sets of clean clothes
 - providing tissues and wipes

Activities, Resources and Repairs

- Before purchase or loan, we check equipment and resources to ensure that they are safe for the ages and stages of the children currently attending the setting.
- We keep a full inventory of all items in the setting for audit and insurance purposes.
- The layout of our play equipment allows adults and children to move safely and freely between activities.
- All our equipment is regularly checked for cleanliness and safety, and any faulty or dangerous items are repaired or discarded.
- We make safe and separate from general use any areas that are unsafe because of repair needed.
- All our materials, including paint and glue, are non-toxic.
- We ensure that sand is clean and suitable for children's play.
- Physical play is constantly supervised, children are supported to take calculated risks depending on the activity.
- We teach children to handle and store tools safely.
- If children fall asleep in-situ, it may be necessary to move or wake them to make sure they are comfortable, we check them every 5-10 minutes.
- Children learn about health, safety, and personal hygiene through the activities we provide and the routines we follow. Hand washing and nose blowing posters are displayed in various places to remind everyone of the importance of correct procedures.

Jewellery and Accessories

Our staff do not wear jewellery or fashion accessories, such as belts or high heels, that may pose a danger to themselves or children. Only wedding and flat rings are allowed (in line with our Staff Code of Conduct).

We ensure that hair accessories (clips) are removed before children sleep or rest.

Safety of adults

- We ensure that adults are provided with guidance about the safe storage, movement, lifting and erection of large pieces of equipment.
- We provide safe equipment for adults to use when they need to reach up to store equipment or to change light bulbs.
- We ensure that all warning signs are clear and in appropriate languages.
- We ensure that adults do not remain in the building on their own.
- We record the sickness of staff and their involvement in accidents. The records are reviewed termly to identify any issues that need to be addressed.
- We share Public Health and Government advice/regulations with staff.

Control of Substances Hazardous to Health

- Our staff implement the current guidelines of the *Control of Substances Hazardous to Health Regulations (COSHH)*.
- We keep a record of all substances that may be hazardous to health - such as cleaning chemicals, or gardening chemicals if used and where they are stored.
- Hazardous substances are stored safely away from the children.
- We carry out a risk assessment for all chemicals used in the setting. This states what the risks are and what to do if they have contact with eyes or skin or are ingested.
- We keep all cleaning chemicals in their original containers.
- We keep the chemicals used in the setting to the minimum to ensure health and hygiene is maintained. We do not use:
 - bleach
 - anti-bacterial soap/hand wash, unless specifically advised during an infection outbreak such as Pandemic flu or Covid-19
 - anti-bacterial cleaning agents, except in the toilets, nappy changing area, and food preparation areas.
- Anti-bacterial sprays are not used when children are nearby.
- Environmental factors are considered when purchasing, using, and disposing of chemicals.
- All members of staff are vigilant and use chemicals safely.
- Members of staff are advised to wear protective gloves when using cleaning chemicals.
